- II. Dr. Kirkby, Associate Dean
  - i. CRM update

We will be doing in house testing and will be calling on coordinators to test their part. Will be looking for bugs as we begin testing. We will have training sessions for coordinators, and there will be a staggered roll out for each program. We are also considering the purchase of additional licenses.

### E. Proposal for Fourth Year of GA Support for dual degree students

This proposal was brought to the council at the September 2018 meeting by Dr. Phil Pfeiffer, who requested that we revise the Graduate Assistant policy to enable students to obtain more than two years of support for students who are seeking dual or parallel masters degrees. The Policy Purpose: The policy specifies the maximum

appointment and award lengths for Graduate Assistants (GA's) and graduate Tuition Scholarships (TS's) respectively. Dr. Kirkby drafted the wording for the revised policy, which Graduate Council members read and provided feedback. Several items were discussed, and it was decided that more research and revision are needed. Dr. Marks said this policy would be revisited at next council meeting.
