OBSERVATION HOURS & CLINIC CONTACT INFORMATION**

Please review the following requirements and information about observation hours.

- Students are **required** to obtain **8 hours** of observation no sooner than 6 months prior to the application due date (i.e. September 1st - March 1st). Please see the [observation hours log](#) for keeping up with hours and instructions on how to turn them in when they are due.
- Students must bring a copy of the [Observation Student Eval Form](#) for the host/sponsor to fill out at each facility they observe. The host/sponsor listed below will keep the form and submit it to ETSU.
- Students can get up to 18 observation hours, and receive up to 10 points towards their application. The extra 10 observation hours must be obtained at a different facility than the original required 8 hours.
- Students **must** get their observation hours at a hospital and with an X-Ray tech.
- Students who use a Ballad Health Facility for their observation hours need to contact one of the sponsors/hosts listed on the follow page for permission to observe them **prior** to filling out the [Ballad Health Observation Application](#). The application requires students to list their sponsor/host. Please review the [observation requirements](#) listed on the Ballad Health website. If a student is not planning to observe at a Ballad Health Facility, they will still need to reach out to the contact to obtain permission to observe, and to find out if any additional paperwork needs to be filled out for that facility.
- Students who are from out of state or a different area of TN, observation hours still need to be obtained at a hospital with an X-Ray Tech. The facility will need to be approved by the program director Ms. Erica O'Quinn, her email is oquinne@etsu.edu.
- Students need to submit their observation hours log form in the application by March 1st. The application is available January 2nd – March 1st on the [Radiologic Science Website](#).



****Most of these facilities are Ballad Health, please see the Ballad Health bullet point above for further instructions on getting your hours set up. NOTE: Ballad Health facilities can take up to 3-4 weeks to get you approved for observation, please start reaching out to these facilities and sponsors sooner rather than later. The deadline for these hours to be completed is March 1st.**
