



RADIOLOGIC SCIENCE PROGRAM FACULTY CONTACT INFORMATION

A minimum of 8 observation hours are required to qualify for an interview, and every hour over 8 will count as 1 point/hour up to a total of 10 points. Observation hours must be completed in diagnostic radiology and must have been completed **within 6 months of the interview**. Prospective students should plan accordingly to NOT carry a phone and to **wear appropriate dress** (casual and no jeans) during observation hours.

It is often helpful to observe at two or more facilities, and **you may observe at facilities not on this list**. Contact Erica O'Quinn (equinne@etsu.edu) to approve additional sites not listed. Complete the Ballad Observation/Shadowing process prior to observing at Johnson City Medical Center, Franklin Woods, Indian Path, Sycamore Shoals or Unicoi County Hospitals.
