Old Business

 Dr. Joe Sherlin and Bill Rasnick visited to talk about the parking situation on campus and have a proposal. They are well aware that parking is a concern for students and that it is hard to find a parking space in the center of campus

- during peak hours. They have put together a plan for a parking garage near the mini dome.
- Bill Rasnik speaks about the growth the the student population and how we need to progress with some of the issues that arise with that growth. All of the master plans are on the website. Last year there were about 500 parking spaces added, about 350 of them were the Jack Vest lot and the other 150 were the spaces on campus were from relining the spaces and shrinking or redirecting the lines. It is concerning that students are parking in businesses parking lots and the businesses don't like that. (e.i. backyard burger, McDonalds, Carnegie parking garage, etc.)
 - Where the parking garage is projected to be is the parking lot on the West side of the Mini dome adjacent to State of Franklin Road this will allow us to gain about 1200 spaces
 - Senator Neblett brought up discussion about a gradual increase of fees like how MTSU is intending to do their garage. The initial look is that may happen and it would be addressed as the phases of the garage were built and then would be instituted as a permanent parking fee.
 - Senator Walker wanted to know about the addition of the coffee shop or bookstore into the garage and if that were able to be changed and yes that is not set in stone and it is up for discussion.
 - Senator Collins wanted to know what would happen with the permanent fee after the garage was built. Bill Rasnick answered that it would be put into a macro parking fund. If the top roof could be made into a green space for students to enjoy. And that students don't want another eyesore on the campus like the Culp Center.
 - Senator Walden makes a motion to support parking garage.
 - Seconded of Senator Dalton
 - Motion passes 20-0-0

 - Senator Neblett was wondering how international travel would impact the number of students the B.U.C. Fund asks for it to affect.
