- B.U.C. Fund Consent Calendar
  - o Move to adopt Calendar with the pulled items Senator Neblett, second Senator Reed
  - Diversity Events: motion to make exceptional benefit Senator Neblett, Second Senator

- Senator Galloway wanted to know why this was voted to fully fund? Senator Collins responded that previously the events brought by diversity events have been really popular. Buctainment receives a SAAC allocation and it did not seem appropriate to allocate these funds
- Senator Sabri wants to know when? March 31<sup>st</sup>
- Senator Huffines wants to know where: Brooks Gym
- Senator Sabri wanted to know why Brooks? Representative for Diversity events says they chose that because

- Roll call vote to deem exceptional benefit
  - Pass 22-0-0
- Move to fully fund Senator Neblett, Second Senator Price
- Diversity events fully funded with a vote of 22-0-0

  - Senator Neblett: wants to know if the funding is just for food?
    - The food is to draw people into the area and then distributing information to talk about what their service is
  - Senator Neblett moves to fund \$430, second Senator Clark
  - Roll call vote: Pass 19-3-1

- Committee member Price says that he would change his vote of no to yes.

- Senator Neblett wanted to know why the committee moved to fund \$700 instead of fully funding. Chair Collins: stated that the conference could seem to find a space on campus comparable to that of the Carnegie therefore reducing.
- Senator Keane moves to fund \$1500, Second Senator Huffines
- Roll call vote passes 16-6-0
- East Tennessee Dharma Community
  - Senator Reed pulled this because this brought up last semester and there was an amount change. There was more money for advertising
  - Senator Collins wants to encourage everyone to review each application independently
  - Motion to fund the\$1500 recommendation Senator Galloway, Second Senator Williams
  - Pass 14-7-1
- Student Academy of Audiology: pass
- Sculpture Society: pass
- o Motion to reinstate the rules Senator Collins, Second Senator Reed
- Legislation SGA-126-11
  - Sponsor Collins states that this is presented on behalf of FMLA and LGBTies and the options for living with a roommate is that the one option for a smoking/nonsmoking roommate is out of touch with current times. Dr. Burchette says that they are in the process of changing the questionnaire, but to non-important questions like what kind of books, movies they like.
  - Co-Sponsor Huffines says that the amount of students that this would affect it would be substantial
  - Sponsor Collins says that this is only requesting a survey of the student body not for it to go into immediate effect.
  - Sponsor Leftrick signed on to this because the only person he knew coming here was a female and it would have been easier for him to have roomed with her because she was the only person he knew.
  - Motion to adopt Senator Neblett, Second Senator Belanger
  - Senator Wolfe wanted to know how many students request this exemption, Senator Collins replies that is very few and that's because it would be under a medical exemption.
  - Senator Huffines thinks that more people would take this option if they were actually given it.
  - Senator Collins says the legislation calls for a committee to be set up in order to address this problem, to see what the best way would be to ask the questions to go on the survey.
  - Senator Fisher wants to know what other preferences would be added, Senator Collins says that these are preliminary questions and would be expanded upon.
  - Senator Neblett says that the only exception to this is in Buc Ridge and only if you're brother and sister. Would this go to all dorms? Sponsor Collins replies that the most success at the other colleges used it in apartment style housing. And he is reiterating that this would not be random male/female roommates.
  - Senator Galloway wants to know if there was any way to make the exception a little
    easier to do instead of calling it a medical excuse. Sponsor Collins says that it was
    considered and the problem was that it was an exemption and that makes it be viewed
    as not the norm, or a special situation.

- Senator Collins requests a roll call vote
- Passes 19-3-0
- Legislation SGA-127-11
  - Move to roll to next week's meeting because there was no committee meeting

  - Sponsor Collins states that this requests gender neutral restrooms on campus. This asks to change the signage for the restroom. There would 44 restrooms that could be changed and they cost about \$10 each and that would bring the total to \$440.
