  - Senator Clark yields his time to President Hall who states that if all these fees are broken down some employers will not pay for some of these fees. He then yields this time to Dr. Lee who states that there is an education tax and this would make something bad happen which would end up hurting a lot more students than help students and this in turn makes it an IRS question. So this actually benefits students on taxes.
  - Senator Collins wants to know what students did prior to 2008 when the change happened. Dr. Lee answers that the tax law changed along with the change in the system.
  - Senator Leftrick says that wouldn't the IRS already know about these changes then? President Hall says that it has to be a viewable. Senator Leftrick says that if we put it online it has to be taxed, but not on a piece of paper. Dr. Lee says that it's not a matter of we are trying to hide it from the IRS. It's a matter of if the fee is charged as a block then it's easier to be handled that way and then the IRS allows them to be taxed that way. There are certain categories that they do not include in that fee. It's not illegal, it's not deceptive, it is just the way it's done.
  - Senator Collins says that this is a bunch of malarkey and this is immoral. I don't understand why the students can't know where the money goes.
  - Senator Sabri says the IRS knows where the money goes; it's just another way to classify where it is going. And he is not supporting a bill that will cost students money.
  - Senator Reed wants to know if it is broken down anywhere on the website and the answer is no.

- Senator Price did some research on this through the Veterans Office and basically a
  whole lot of veterans would be harmed by this transparency and wants to know why we
  are debating this that will hurt a lot more students that it will help.
- Senator Clark says that if this bill practically going to be harmful to the students then why are we supporting it. And feels like this resolution has ulterior motives.
