Senator Matthew Huffines, Senator Donovan Reed, Senator Adam Jarvis and Attorney General Jacob Baggett, present the following legislation to the East Tennessee State University Student Government Association on behalf of the Wayne G. Basler Center of Physical Activity and its staff.

**A RESOLUTION TO EXTEND THE OPERATIONAL HOURS OF THE WAYNE G. BASLER CENTER FOR PHYSICAL ACTIVITY ON A SEVEN-WEEK TRIAL BASIS IN ORDER TO DETERMINE AND MEET THE GROWING NEEDS OF ITS PATRONS LOCATED BOTH ON AND OFF CAMPUS.**

**Whereas**, the Wayne G. Basler Center for Physical Activity also known on campus as the C.P.A. has provided facilities that are first rate, and its staff members are of the highest caliber, and;

**Whereas**, such quality facilities and staff often stimulate great demand for use from students and members in the surrounding area, and;

**Whereas**, the current operating hours are in place to provide the absolute best service possible to the facilities' patrons, and;

**Whereas**, explicit and overwhelming interest in extending the C.P.A.'s operational hours has come to the attention of the Student Government Association, and;

**Whereas**, the Director of Campus Recreation was contacted as to the possibility of extending the C.P.A.'s operational hours with the intent to better meet the needs of the Center for Physical Activity's patrons, and;

**Whereas**, Mrs. Lynn Nester, Director of Campus Recreation at East Tennessee State University, was consulted in order to address this matter, and;

**Whereas**, after discussion and consultation with her co-workers and co-professionals, Director Nester is in full support of eliminating the extended weekend closings of the C.P.A. during Martin Luther King and Labor Day weekends as well as extending the Monday through Thursday operational hours on a trial basis.

**NOW THEREFORE BE IT RESOLVED BY THE 2010-2011 STUDENT GOVERNMENT ASSOCIATION SENATE OF THE EAST TENNESSE STATE UNIVERSITY THAT:**

**Section 1:** Campus Recreation will extend the Monday through Thursday operational hours of the Center for Physical Activity on a seven (7) week trial period beginning at the conclusion of the 2011 Spring Break.

**Section 2:** This trial period will include an extension of the Monday through Thursday closing time of the C.P.A from 11:00 p.m. to 12:00 a.m.

**Section 3:** During the 2011- 2012 school year, the C.P.A will now hold weekend hours on both the Saturday and Sunday of Labor Day and Martin Luther King weekends.
