- I. Call to Order by Vice President Sholes at 4:00 pm
- II. Roll Call
 - a. 28 of 30 Senators present
 - i. Absent Senator Cassada
 - ii. Absent Senator Sharp
- III. Reading of Minutes
 - a. Passes: All in favor
- IV. Open Forum
 - a. Carter Warden came to talk to us about the Spring concert. The genre is "Other". He showed us some of the options for the concert that the students will be voting on.
 - b. Senator Bolling stated that Buctainment is bringing a similar dance party to campus during BucStock so the dance parties should not be voted on behalf of the student body. The vote failed to remove it from the list.

 - a. BUC Fund (Attached is the consent calendar)
 - b. The applications that were pulled include: FMLA, Counseling Center/Student Affairs, SORC: LeaderShape, NPHC, Carter Stone Powell Hall Council, Edge Club, PHC, IFC, and NPHC, AIHS
 - c. Senator Johnson moved to approve the consent calendar to fund SAYC and NHRR the amount recommended by BUC Fund. Seconded by Senator Hancock. The vote passed 26-1-1
 - i. Senator Johnson pulled PHC, IFC, and NPHC due to it being contradicting to BUC Fund funding past affiliations to attend conferences. Senator Jamison stated that he voted not to fund it because it is not a mandatory event by the affiliates. Senator Johnson made a motion to fund \$7,050 and Seconded by Senator Baird. Senator Thwing objected due to us not having that much money in our off campus budget. The motion failed to fund the organization that given amount. Failed: 15-12-1. More discussion occurred. Senator Johnson moved to fund the organization \$3,530 and Seconded by Senator Shah. Senator Johnson made a call to previous question. Seconded by Senator Holland. The vote was to fund them \$3,530 and it failed 11-14-2. Senator Johnson made a

motion to fund them \$3,300 and Seconded by Senator Baird. Senator Faircloth made an objection just to fund them \$0. The objected failed 9-16-2. Senator Johnson called to previous question and Seconded by Senator Hancock. Senator Holt objected due to him wanting to speak. It failed 11-14-2. The Senate voted to fund them \$3,300 it passed 16-8-3.

- ii. This event was pulled due to it the amount requested, SORC:Leadershape. Senator Johnson made a call to previous question and Seconded by Senator Wangari. It passed 26-0-1.
- iii. Carter Stone Powell Hall Council was pulled because BUC Fund decided to fund less due to the money going towards food and Senator Shah felt like free food will bring people to this event. Senator Shah made a motion to fund them the full amount requested of \$420 and it was Seconded by Senator Petrak. Call to previous question made by Senator Ellis and Seconded by Senator Cuculovska. The vote passed to fund them the full amount requested for 18-7-2.

Roll changed to 27 of 30

- iv. Senator Holland pulled Edge Club due to it being open to the entire student body and affecting many people. Senator Carpenter stated that in the BUC Fund meeting that it was said that this event will help people in their future endeavors (professional development). Senator Jamison stated that during the meeting it will be advertised to a specific portion of the student body. Call to previous question made by Senator Johnson and Seconded by Senator Bolling. The motion passed to fund the Edge Club \$0 passed 26-0-1.
- v. Senator Hancock pulled this piece, AIHS, to hear more discussion because the students were not in attendance for the meeting, but more information was given later to the BUC Fund committee. Senator Holt made a motion to fund the requested amount of \$800 and Seconded by Senator Wangari. An objection was made by Senator Johnson based off hearing Attorney General Unland's ruling of the constitution. It failed 9-16-2. Senator Johnson made a motion to extend time by 10 minutes and it was Seconded by Senator Cuculovska. There's been a motion to recess by Senator S Tuggle and Seconded by Senator Baird. Senator Holt objected because he felt like we should handle it now. It passed 12-15-1. We voted yes to recess by 20-7-1. A call to previous question was made by Senator Johnson and seconded by Senator Holt. An objection was made by Senator Bolling due to amount requested for printing when they can have printing in the SORC. A revote had to occur due to Vice President Sholes confusion due to the voting on the objection, it passed 24-2-0. The vote failed 14-11-1. The Senate voted to fund them \$800 and it passed 18-8-1.

Roll changed to 25 of 30

- vi. FMLA was automatically pulled due to the amount requested. This is the second time this organization applied for funding. Senator S Tuggle made a motion to extend time by 10 minutes and it was Seconded by Senator Bolling. A motion to extend time was made by Senator Baird and Seconded by Senator Parks. Senator Holt made a motion to fund FMLA \$0 and Seconded by Senator Petrak. Senator Parks made a motion to extend time by 10 minutes and Seconded by Senator Southers. The Senate voted to fund FMLA \$0 and it passed 14-10-1.

Senator Bolling made a motion for a five minute recess and it was Seconded by Senator Zaragoza.

- vii. This application, NPHC, was pulled automatically due to the dollar threshold. Senator Hancock called to previous question and it was Seconded by Senator S Tuggle. It was approved to be funded the amount recommended by the BUC Fund by 23-0-1.
- viii. This application, Counseling Center/Student Affairs, was pulled automatically due to the dollar threshold. Senator Johnson called to previous question and it was Seconded by Senator Bolling. Senator S Tuggle objected due to it being a hasty decision and it deserves to have full funding. The objection failed 11-12-2. The Senate voted to pass the Counseling Center/Student Affairs the recommended amount of BUC Fund, \$6,000, and it passed 19-4-2.
