A RESOLUTION TO FORMALLY DENOUNCE THE ACTIONS TAKEN BY THE ADMINISTRATION TOWARDS STUDENT PARKING ON THE EAST TENNESSEE STATE UNIVERSITY MAIN CAMPUS.

WHEREAS, student parking is an unresolved issue on the ETSU main campus; and,

WHEREAS, the Administration, over the summer, reclassified lot 12 as well as pave over numerous parking spaces at Lucille Clement living residence; and,

WHEREAS, the Administration, also over the summer, entered into a one year contract cutting the hours of the BUC Shot service; a service that directly influences students and their well-being; and,

WHEREAS, student input, either through the Student Government or whole student body consensus, should be taken into consideration when considering making major parking changes that will greatly affect students; and,

WHEREAS, neither the student body, the Student Government Association, or even the Executive of the SGA were informed of the aforementioned changes; and,

WHEREAS, it is the <u>Right</u> of the student body to have covenant, safe, and accessible parking.

NOW THEREFORE BE IT RESOLVED BY THE 2014-2015 STUDENT GOVERNMENT ASSOCIATION SENATE OF THE EAST TENNESSEE STATE UNIVERSITY THAT:

Section 1. The Student Senate, the legislative body of the Student Government and the Representatives of the students, hereby formally denounces and condemns the actions taken by the administration violating the Parking rights of the students of

East Tennessee State University by unilaterally removing student parking.
