

The **University Judicial Committee** shall be composed of the Associate Dean of Students, President of the Student Government Association (SGA), Chief Justice of SGA, an Associate Justice, and three of the faculty members appointed to serve by the Vice-Provost and Dean of Student. Alternates for the Chief Justice and Associate Justice shall be selected by the SGA to hear cases on appeal from the Student Court. Members are appointed to renewable one year terms. Quorum is 2/3 of the composition of the court. Each member shall have (1) vote.

Each member shall be appointed by the SGA president and confirmed by a majority of the Student Senate present and voting. Members are appointed to renewable one year terms. Quorum is 2/3 of the composition of the court. Each justice shall have (1) vote, with the Chief Justice voting only to break a tie.
