- Student hereby agrees to pay to the University the amount of the [Prevailing Rates](#) established by the University and its Board of Trustees for each semester during the term of this agreement for the privilege of residing on the premises and using the dining services program.
- The term of this agreement shall commence August 19, 2022 and shall end May 5, 2023.**
- This agreement is subject to the provisions of the University Board of Trustees' policy on Student Residence Regulations and Agreements available on the Housing website at [Housing Policies](#) and the provisions of the Code of Student Conduct available in the Undergraduate Catalog and the Graduate Catalog at <https://www.etsu.edu/reg/catalog/>.
- This agreement requires enrollment as a student at East Tennessee State University, except in cases where exception is granted by the Director of Housing and Residence Life.
- This agreement specifically incorporates by reference the "COVID-19 Wellness Notice" [available here](#). The COVID-19 Wellness Notice may be revised as necessary to safeguard the health of our students, faculty, and staff. Such revisions may include COVID-19 testing, vaccination, and/or other additional restrictions and requirements.
