Dear Student Organization Presidents:

Many of you are carefully monitoring ETSU's response to COVID 19 (coronavirus). We want to provide some specific communication regarding recommendations for operations of all student organizations. **All university updates** will continue to be emailed to ETSU student e-mail accounts and posted to www.etsu.edu/coronavirus.

In the university update that was distributed (attached) at 5:30 p.m. on Thursday, March 12, 2020 the following instructions were included:

"All ETSU events scheduled through April 13 are cancelled; however, some events may be rescheduled at a later date and updates will be provided. During this time, in-person gatherings or employee/student organization meetings should be minimized. Everyone is encouraged to follow recommended COVID-19 mitigation procedures and social-distancing. Please take advantage of teleconferencing resources available through Zoom."

Student organizations are asked to follow the universities directive in cancelling all inperson events and gatherings scheduled between now and April 13, 2020. Please work to determine what are essential operations that occur through Zoom meetings.

Presidents: Please look at your scheduled organization operations from now through April 13, 2020 and determine:

- What essential operations or deadlines are planned between now and April 13?
- How will you cancel or adapt these to online-only events?*
 - General events
 - Awards deadlines for governing body
 - Voting on bylaws
 - Voting on budget
 - Voting on membership
 - o Election timeline
 - Officer transitions
 - Recruitment of new members
- If you have new members or members you are concerned about, how will you reach out?
- Who else (beside organization members and advisors) should be notified of changes? Building or reservation staff? Catering? Transportation or Security company? Etc.

*This list is not exhaustive, there may be other activities or operations that are specific to your organization.

Please continue to consult and communicate with your advisors and the members of your organization regarding these changes. Let us know if you need to know anything from the
