Old Business

Julie Fox-Horton moved to approve the November 20, 2024 minutes. Jason Davis seconded. The motion passed.

New Business

- New Course - BIOL 4447 Protein Aggregation: From Physiology to Pathology

Anoop Arunagiri provided an overview of the proposed course which fills a gap in undergraduate and graduate curricula. This course is designed to explore protein folding and aggregation, including links to disease, benefits to organisms, and applications in biotechnology.

All UCC members were asked to review the proposal prior to the meeting. Edits completed during the meeting:

- Academic Justification remove critical in the first sentence to leave fills a gap
- Major Assignments The originator was asked to clarify how participation is evaluated.
 No edits were required.
- Grading Scale Undergraduate change to Below 60 = F; Graduate change to Below 70
 = F
- Attendance policy Change first sentence to read attendance at all meetings is expected rather than required.

- Revise Course Substantive Modification (Major) – SPED 4710 Residency 1 Special Education

John Wheeler provided an overview of the proposed course revision which decreases credit hours from 5 to 3 to match the other Residency 1 courses. This course prepares prospective special education teacher candidates as they participate in a mentored/supervised learning experience in local school systems.

A non-substantive curriculum revision proposal is currently at the college level. The curriculum revision proposal will move the 2 credits removed from this course to free elective hours.
